 1. To claim immediately on the Carriers, Port Authorities or other Bailees for any missing packages.

 2. In no circumstances, except under written protest, to give clean receipts where goods are in doubtful condition.

 3. When delivery is made by Container, to ensure that the Container and its seals are examined immediately by their responsible official. If the Container is delivered damaged or with seals broken or missing or with seals other than as stated in the shipping documents to clause the delivery receipt accordingly and retain all defective or irregular seals for subsequent identification.

 4. To apply immediately for survey by Carrier's or other Bailee's Representatives if any loss or damage be apparent and claim on the Carriers or other Bailees for any actual loss or damage for gound at such survey.

4. Survey report or other documentary evidence to show the extent of the loss or damage.

5. Landing account and weight notes at port of discharge and final destination.

6. Correspondence exchanged with the Carriers and other Parties regarding their liability for the loss or damage.

THIS INSURANCE represents and takes the place of the Policy and conveys all the rights of the original policyholder (for the purpose of collecting any loss or claim) as fully as if the property was covered by a special policy direct to the holder of this Insurance.

This Company agree losses, if any, shall be payable to the order of Assured on surrender of this Insurance. Settlement under one copy shall render all others null and void.
